# Advocacy Notes

#### Harriet Tubman Statue & Commemoration Legislation

Maryland HB 1429/SB 1069 passed. The Bill is a request to place a statue of Harriet Tubman, one of Maryland's all time great American heroes, in the U.S. Capitol and for Commemorative Days to be set.

Harriet Tubman's statue would be at no cost to the state of Maryland, as the funding will be provided by nonprofit groups and individual donors. Additional legislation requests declaration of state and national Harriet Tubman Days.

#### Maryland Health Benefits Exchange Act of 2012 (HB443/SB238)

Maryland lawmakers approved legislation establishing the Maryland Health Benefits Exchange Act of 2012. The legislation authorizes the exchange to contract with health insurance providers to place their plans on the exchange starting in 2014. Lawmakers set parameters for what providers can participate in the exchange.

The bill also outlines "navigator" programs for the small business and individual markets, outreach efforts that will ensure the exchange's customers understand how to utilize the exchange.
