### Advocacy for Women's Issues

The Maryland Legislative Agenda for Women (MLAW) received 11 legislative proposals for consideration at its fall conference October 20 in Baltimore. Six members of AAUW Howard County attended the conference.

Titles of the specific proposals were Earned Sick and Safe Time, Employee Abuse Register, Asset Forfeiture for Human Trafficking, Child Abuse—Failure to Report, Tobacco Tax, Akin's Law, Sex Crimes—Fondling During a Burglary, Relief for Victims of Dating and Sexual Violence, Service of Process for Protective Orders, Committing a Crime of Violence in the Presence of a Minor, and Health Occupations—Licensed Midwives.

MLAW members will rank the proposals, and the Board of Directors will affirm the top issues to receive support during the coming legislative session. To join MLAW or to review the proposals, visit

# AAUW LEGAL ADVOCACY FUND AIDS WOMEN FIGHTING DISCRIMINATION

Since 1881 the American Association of Women (AAUW) Legal Advocacy Fund (LAF) has helped students, faculty, staff, and administrators in higher education challenge discriminatory practices such as sexual harassment, denial of tenure or promotion, pay inequity, and inequality in women's athletics programs.

The AAUW LAF was conceived and implemented to aggregate member contributions to invest in activities that prevent and combat sex discrimination and promote gender equity through support of litigation and educational programs. Beginning January 1, 2009, LAF case support was expanded to address discrimination cases that protect women in all workplaces, as well as those that arise in the academic context. Specifically, LAF will seek to support plaintiffs with significant cases that have the potential to set precedent and protect others against discrimination in the future

LAF initiatives include community and campus outreach programs, a resource library and online advocacy tools, and various research reports.

Through the LAF Campus Outreach Program, AAUW branches and members can receive up to \$750 in funding to implement a gender equity-focused program or event at their local college or university. Requests are accepted on a rolling basis.

Topics for campus outreach may include: sexual harassment on campus, sexual assault on campus, equal pay and preparing for the workplace, Title IX in the context of athletics or women in nontraditional fields, and tenure issues for faculty.

LAF also provides support to workplace sex discrimination cases that have the potential to make a difference for all women. The LAF Resource Library provides access to legal information, case examples, statistics, answers to frequently asked questions, and outside resources on various sex discrimination topics.

AAUW LAF is a 501(c) (3) organization. Contributions to LAF are tax deductible for federal income tax purposes to the full extent allowed by the law.

On October 2, LAF had a Fall Conference Call to provide information on the latest LAF programs and updates. The following seven topics were discussed:

- Case support updates;
- AAUW's June activities to support legislation that will help the women workers
  of Wal-Mart and to mark the fortieth anniversary of Title IX;
- An amicus brief update: Fisher v. University of Texas;
- Case Support Travel grants;
- LAF Campus Outreach updates;
- Healthy Masculinity Summit; and
- "It's My Vote: I Will Be Heard."

# Education Committee Sets Practice ACT

AAUW Howard County, in conjunction with the Princeton Review, will sponsor an ACT practice test for high school students on **Saturday, January 12, 2013,** at the Vantage House Auditorium. The "Test Fest," from 10:30 am to 3:30 pm, is modeled after the successful Practice SAT sessions previously offered.

A "Scores Back" Strategy Session will follow on **February 2** from 2:30 to 4 pm, where participants will receive personal reports and learn more about the results.

Taking the practice ACT test under actual testing conditions is a great way for students to try their hands at the types of questions they'll face on the ACT exams. They can build confidence and get comfortable with the testing formats.
