AAUW Howard County, in conjunction with the Princeton Review, will sponsor an ACT practice test for high school students on **Saturday**, **January 12**, **2013**, at the Vantage House Auditorium. The "Test Fest," from 10:30 am to 3:30 pm, is modeled after the successful Practice SAT sessions previously offered.

A "Scores Back" Strategy Session will follow on **Saturday**, **February 2** from 2:30 to 4 pm, where participants will receive personal reports and learn more about the results.

Taking the practice ACT test under actual testing conditions is a great way for students to try their hands at the types of questions they'll face on the ACT exams. They can build confidence and get comfortable with the testing formats.

AAUW Lobby Corps

Lobby Corps is a group of volunteers who meet on Thursday mornings, when Congress is in session, to visit congressional offices to discuss AAUW issues such as equal pay, Title IX, and other concerns important to women. Generally we talk with a legislative aide or leave a note with the receptionist.

Early each week, the paid AAUW leader (Government Relations Manager) sends out an email to each volunteer with information on the bill or topic she has chosen and researched for that week. That Thursday, those who can attend. meet at the cafeteria in either the Longworth House Office Building or Dirksen Senate Office Building. The leader reviews all the background and 'talking points' in the handouts. Then groups of two or three, with new volunteers paired with more experienced members, are given a list of offices to visit.

In January, generally on a Thursday, there is a full day of training held at AAUW headquarters in Washington, D.C. The various AAUW legislative staff members discuss the key policy issues and teach advocacy skills to help the volunteers meet with Senate and House member's staff.
