# A Different Decade

While our articles commemorating our branch's 50<sup>th</sup> anniversary have focused primarily on the early days, a conversation with Diane Roca reminded me that there have been significant changes in our branch in just the 10 years since she served as branch president. Diane has a long history with AAUW, having joined initially in the early 1970's. Although she was not a member for all of the intervening years, she served as Branch President from 2002-2004 and as AAUW State President from 2006-2008, giving her a wide perspective not only on how our branch has changed, but also on how our branch compared to other branches within the state.

The Howard County branch had about 40 members during her tenure and one of her proudest accomplishments was receiving a Gold Award from National AAUW's 21<sup>st</sup> Century Recognition Program. This recognition was the highest offered by AAUW and, quoting from the May 2004 Branch Newsletter: "The award recognizes activities in three areas:

- a project our co-sponsorship of two Candidates Forums with the Howard County League of Women Voters last October;
- our strategic plan and revised branch by-laws
- 3) our support of the Educational
  Foundation and Legal Advocacy Fund.
  This award represents your dedication
  to AAUW as you help with our
  projects, activities, membership
  recruitment and fund raising. You can
  be very proud of this recognition.
  Special thanks to Carol McAuliffe for
  her advice and assistance in
  completing the application."

Taking a peek at newsletters of the time reveals a new logo on the branch masthead, touting the 21<sup>st</sup> Century Award designation. Incidentally, the strategic plan included the goal of increasing membership to 100!

Despite a membership of less than 1/3 of our current number, the branch participated in many fundraising activities. Fifty-fifty raffles were held at every meeting. Sales of cards and wrapping paper as well as the fashion show supported local and state philanthropy.

During this period, the branch also moved from a monthly paper newsletter to on-line publishing and distribution. Diane recalled the mangled paper copies that sometimes resulted from mailing and the frustration of moving to ever-more expensive cardstock as a means of delivering a readable product. The changeover required many months of asking/prodding members to make the switch without losing those who were uncomfortable with technology.

One of the priorities the branch pursued for its 40<sup>th</sup> anniversary celebration was outreach to charter members whose membership might have lapsed, but were still in the area. Remarks were delivered by Betty Jane (BJ) Fisher, a founding member of the branch. The celebration

took place in a building on the grounds of St. John's Episcopal Church and was well-attended by current and past members, who enjoyed cake and champagne. Congratulatory proclamations from the governor and the county executive were presented.

Reflecting on her experiences as branch and state president, Diane said she appreciated the opportunity to interact with so many talented and committed women. She noted that each of the branches she visited were unique in what they felt called to do. The unique blend of personalities, experience, passion and local need really hampered finding many common state-wide causes that would knit the branches together, but also resulted in the implementation of many projects that benefitted from the time, treasure and talent of local AAUW teams

Ms. Roca commented on the role of AAUW leadership and respect for the many demands on members' time and talents, saying "whatever you do needs to fit within the limits of members' energy and ability." Both then and now, this practical approach gives AAUW plenty to work with!
