# The Lilly Ledbetter Fair Pay Act

5th anniversary was on January 29. It was introduced (sponsored) by our own Senator Mikulski and was the first bill signed by President Obama. The law extends the 180-day statute of limitations for filing an equal-pay lawsuit for pay discrimination by 'resetting' the time limit with each new paycheck affected by that discriminatory action.

# Maryland Legislative Agenda for Women

MLAW's (detailed information may be found via the following link - <a href="http://mdlegagendaforwomen.files.wordpress.com/2013/12/mlaw-2014-agenda-sign-on.pdf">http://mdlegagendaforwomen.files.wordpress.com/2013/12/mlaw-2014-agenda-sign-on.pdf</a>) selected initiatives to support before the General Assembly:

- Earned Sick and Safe Time Act: workers to earn a limited number of annual paid sick and safe days.
- Parental Leave at the Birth or Adoption of a Child: expands legally protected job security
- Pregnant Detainees and Inmates-Restraint Restrictions: prohibit restraints from being used on an inmates during certain trimesters of pregnancy with except for the safety of the offices.
- Permanent Final Protective Orders: second-degree assault not have to actually serve but only to be sentenced to a term of five years.
- · Akin's Law: rape victims to terminate parental rights of rapists
- Relief for Victims of Dating & Sexual Violence: remove sexual assault out of the Peace Order statute and the Protective Order statute.
- Protective orders: changes the burden of proof to "a preponderance of the evidence."

# "Bridg-ing" Fifty Years of AAUW

When B.J. Fisher, co-founder and past president of AAUW Ellicott City Branch (1967-69) recalls the highlights of her involvement in the organization, her eyes light up remembering the many friends she made. B.J. recently reminisced about her experiences, recalling that the impetus for starting the branch was a meeting of the College Club of Baltimore that she attended with Bonnie Sisk. "The ladies seemed so ancient," she chuckled. As recent college grads and young mothers themselves, she and Ms. Sisk decided to see if they could gather and organize other younger women who were college graduates in the Howard County area. They put ads in the local paper, contacted local college alumni offices and talked to teachers in the local schools. There was a growing interest in activities that would get college-educated women out of the house and allow them to socialize, keep up on current events and satisfy their need to be "more than mommies."

B.J. emphasized, however, that they didn't want to just be a social organization. They also contacted the state AAUW office to find out what they would need to do to charter a branch. The process was complex and timeconsuming. She recalled that there was then (as now) a small group of women who wrote and re-wrote the nascent organization's by-laws, researching and consulting with other branches. After much work, they received their charter in January 1964. According to documents from that period, they had grown to 25 members. Bonnie Sisk served as the first president of the Ellicott City Branch.

Ms. Fisher, who is the mother of six, says she was a "reluctant president." "There was a small core of us, and everyone had to take their turn," she recalled ruefully, "I really never liked public speaking," she said with a slight shiver. Despite her modest approach, B.J. served in a variety of official roles during the early years of the branch's existence. When asked what she most enjoyed, she mentioned the membership teas and legislative briefings as well as museum and embassy trips. She recalled participating in the Oella preschool project as well, actually driving around the Oella community and

collecting the preschool children who would participate. "More than once," she said, "I wondered how I got myself into this." In the end, however, she recognized the benefits the children had derived through their efforts.

Ms. Fisher was quick to clarify that for a variety of reasons, she was not a continuous member of AAUW for fifty years. Work and home obligations and the loss of friends in the group made her involvement more sporadic and membership took a back seat to life's demands. One of the enduring benefits of her AAUW experience, however, has been a bridge group that has met regularly for almost 50 years! One of the criteria for inclusion was having belonged to AAUW. This group of friends, averaging eight members, some constant, some substitutes, rotating in and out, meet at members' homes and keep in touch through a lifetime of ups and downs. Ms. Fisher said sadly that lately, it has become harder to "find a fourth," but she clearly knows what's going on in each of her bridge partners' lives, and after fifty years, the friendships trump the cards.

# **Diversity: Reflections in My Family's Mirror**

In 1950, my father found a job with the Census Bureau in Suitland, Maryland. Although we lived in Philadelphia, Dad chose to commute to work. One day, his secretary asked if she could get off a little early to catch a train to Philly, where she was to visit a friend. Over her objections, he insisted that he would drive her to her friend. She actually had a reason not to go with him-- prejudice—not her prejudice, but society's. My father had not considered the possibility that traveling with his African American secretary would present a problem when they stopped for dinner. It did. After being ignored at one restaurant, they moved to his favorite, Howard Johnson's. Still, no one would wait on them. He was livid, but gave up and ordered hot dogs to go.

In 1955, I was a freshman in high school, when one of my classmates asked if I were Jewish, as she had heard. She had never known anyone who was Jewish (actually, there were very few of us in the school), and the only thing she "knew" about us was that we did not believe in God. What? I could not believe it. I told her that we should have lunch together and I would educate her on Judaism. I started off with this question: Have you heard of Abraham?

One of my daughters and my son also had interesting high school experiences- and both concerned the National Honor Society. My daughter's did not come to light until several years after graduation. Her (still) very close friend admitted that in high school she thought she could not have a friendship with anyone who was not a member of the Honor Society. It was through her older sister's friendship with my older daughter that she learned an important lesson: It's possible that a smart and good person may not be a member of the NHS. While in school, my son, invited to join, declined the offer. He said he refused because of the attitude that members are better than non-members. (If AAUW were open to everyone, regardless of educational level achieved, think of the diverse ideas it would afford us.)

I became a mother-in-law three times, and each brought diversity to our Jewish family. In 2000, after the wedding rehearsal of my daughter and her Catholic fiancé, the cantor came up to me and stated that she loved seeing the diversity of their friends, who were a part of the ceremony, and that it was "...like being at the United Nations." My older son-in-law studied for four years and was ordained a Catholic Deacon last spring. He may be an unusual Deacon, as he can light the Chanukah candles. One day, when my daughter was in the ER, he was at home with their four-year old. I had taken my daughter to the hospital and while she was on the drip, her phone rang. I listened to her slowly recite the prayer said over the Chanukah candles. Her husband had called to get help in lighting the candles, because he believed that their daughter should not miss this important part of the holiday. He and my other son-in-law take part in our holiday celebrations and attend special synagogue services. We do the same with them, attending special church services, as well as being part of Christmas and Easter dinners. All my grandchildren speak of their fathers' Christmas trees, which they enjoy decorating.

In 2010, when my son told us that he was dating a young woman in Chicago and gave her name, I remembered having met her family a few years before, when I was in Chicago. By the last name of the family, I had "assumed" (always a tricky thing to do) that the family was Jewish. My son and his fiancé were married by a cantor and a judge, both close family friends of her parents. Their home also includes a Christmas tree as well as a Chanukah menorah, matzo and Easter eggs. My daughter-in-law is always part of our Jewish celebrations and is with us, of course, for Christmas and Easter-- if she and my son are not in Chicago.

My nine-year-old granddaughter correctly pointed out that I am not a math genius; but, I cannot resist stating that all of these situations have a common denominator: education--although sometimes a lack of it. What reflections are in your mirror and what can we add to all of ours? Let us do all we can to bring greater diversity into our Howard County AAUW branch to help it continue to grow in depth, along with its numbers.
