## Get Ready for Test Fest – the Practice SAT

It is time for Test Fest, the practice SAT exam that AAUW Howard County sponsors as an educational and fundraising project. Test Fest will be held **Saturday, March 23** from 10:30am to 3:30pm at the Vantage House auditorium. A follow-up "scores back" session to discuss test results will be held **Saturday, April 20** from 2:30pm to 4 pm at Vantage House.

Princeton Review, which administers and scores the tests, is the AAUW partner on this project. The \$15 registration fee covers both sessions and is donated to the AAUW scholarship fund.

Test Fest gives high school and middle school students an opportunity to take a full-length practice SAT under actual testing conditions. It's a great way to try out the test, build confidence, and get comfortable with the exam formats. Preregistration at www.Princetonreview.com is required for both sessions.

## Advocacy Corner

#### Violence Against Women Act

On February 12, 2013, the Senate voted to reauthorize the Violence Against Women Act with a strong bipartisan vote (78 to 22). This would revamp domestic violence programs and extend the law's protection to gay men and lesbian women on tribal reservations. The Senate version also would expand efforts to combat sex trafficking. The statue provides grants to state and local governments to assist in the prosecution of abusers and rapists and to fund services for victims. The Violence Against Women Act was first passed in 1994.

#### Legal Advocacy Fund Update

AAUW adopted the case of Virginia LeBlanc in December 2012. LeBlanc, the former director of the Hudson and Holland Scholars Program at Indiana University, a scholarship program that primarily serves African American students, filed a complaint in federal district court against the university claiming gender and pay discrimination when she tried to resolve the pay disparity internally. Settlement talks are scheduled for March, and if necessary, the case will go to trial in April 2014.

On January 23, 2013, AAUW Board of Directors member Kathy Braeman and Program Manager Holly Kearl sat in the overflow room at a hearing at Lackland Air Force Base in San Antonio, Texas on the widespread of sexual misconduct at Lackland. Kearl wrote a blog post on the hearing that led to an <u>interview</u> and an invitation to <u>write for the Huffington Post</u> about the military sexual assault survivors who are participating in the LAF-supported lawsuits.

The Women's Legislative Briefing was held on January 27, 2013 in Rockville by the Montgomery County Commission for Women and other sponsors. Senator Barbara Mikalski spoke on social and economic equality. Dr. Bernice Sandler, the "Godmother of Title IX," made the Keynote Speech.

A congressional panel comprised of Senator Benjamin Cardin, and Representatives John Sarbanes and John Delaney discussed women's legislative issues. The remainder of the program consisted of small seminar groups that addressed various women's issues. Participates were able to choose two areas of interest to attend. ## Looking Back...

#### Celebration of the 40<sup>th</sup> Anniversary of Title IX

Did you know that the landmark civil rights legislation Title IX started in Maryland? The fascinating story of its enactment was told at a celebration of the 40<sup>th</sup> anniversary of the legislation at the Maryland Women's Heritage Center in Baltimore. Did you know that AAUW played an important role too?

Lorraine Tropf and Diane Roca attended the celebration on December 7.

Dr. Bernice Sandler, known as the Godmother of Title IX, was the featured speaker. In 1969, she was a part-time instructor at the University of Maryland. There were tenure track openings that she was qualified to fill, but was not considered for them. Feeling that the reason was sex discrimination, she started to research the law and, astonishingly, could not find anything in the law that prohibited discrimination against women. With further research, she found that a clause in the recently passed Civil Rights legislation did prohibit sex discrimination. On that basis Bernice filed a Class Action suit against the University of Maryland and other universities. Her efforts generated a flood of letters of support. Many women joined in the effort, initiated a letter-writing and telephone campaign to propose the legislation. Dr. Sandler searched for newsletters about women's issues and were distributed to and directed at women. She found AAUW was the only organization at that time with a newsletter directed to and for women. Dr. Sandler said that AAUW was instrumental in helping to get the word out.

The celebration's program came to life with updates on current equity issues and stories from women who are presently involved in ensuring its compliance. There were accounts from attorneys, educators, and activists. Attendees were given the chance to share their own stories about life before Title IX or how it changed their lives after the law was passed.

Many of us associate Title IX with women's sports. However, it prohibits discrimination on the basis of sex in all federally funded education programs and activities. From this legislation, many significant changes including sports programs and facilities in schools for girls and women, a climate that recognizes women's abilities in STEM (Science, Technology, Engineering and Math), and protection from sexual harassment and bullying.

We felt honored to be part of the celebration of this landmark legislation and to stand side by side with the pioneers and present day guardians. Lorraine Tropf and Diane Roca President and Co-Vice President, Secretary
