Great Decisions starts a new discussion year in January. The first meeting of 2012 is Monday, January 16, from 7 to 9 pm at the home of Diane Roca.

Great Decisions is a grassroots discussion program sponsored by the Foreign Policy Association to promote citizens' knowledge of world affairs

Topics for 2012 are Middle East Realignment, Promoting Democracy, Mexico, Cybersecurity, Exit from Afghanistan and Iran, State of the Oceans, Indonesia, and Energy Geopolitics. FPA publishes a book with articles on the topics and discussion questions. The group members purchase the book and read the article before the meeting. At meetings, we start by watching a DVD with a PBS program on the topic. Our discussions are informative and fun.

We will meet eight times and discuss one topic at each meeting. Meetings will be January through May on the third Monday of the month at 7 pm. There will be a summer hiatus June through August. The group will resume meetings in September and October on the third Monday. In November, we will hold our final meeting of the year on the SECOND Monday because the third Monday occurs during the busy Thanksgiving week.

Elected School Board Winners Share Tips So You Can Do It Too

In November the League of Women Voters of Howard County, along with co-sponsors PTA Council of Howard County, Conexiones, the Association of Community Services of Howard County, NAACP, Jack and Jill, American Association of University Women and the Korean American Community Association of Howard County, held a panel presentation at the George Howard Building. Among those on the panel were former School Board member Pat Gordon, Diane Mikulis and current member Cindy Vaillancourt. The event was moderated by Valerie Montague, who posed a myriad of questions that had been submitted by school board candidate hopefuls, about twenty of whom were in the audience.

Tried and true methods of running a campaign were discussed. Some of the more crucial points made were every candidate needs to be certain to obey the campaign finance laws, work with the amount of money that you put in or are able to raise; meet and greet your constituents; and always be prepared for the media.

One of the comments that stood out was that the school board would like to have representation from single parents. Considering the amount of time and energy required to run a successful campaign, running for the school board seems to be a bit of out of reach for many single parents.

Stay tuned to the Howard County Board of Elections as the Maryland primary elections dates have changed for 1012: **February 18** - Absentee ballots will be mailed out by the Board of Elections **March 24** - Early voting begins **April 3** - Primary Election Day **October 27** - Early voting for the Presidential election begins

November 6 - General Election Day

Update on Advocacy Issues from National

On November 9, there was a conference call for all AAUW members and it was organized by Seth Chase, field director for Developing Grassroots Advocacy Leaders. The purpose of the conference call was to provide an update on the Pay Equity Bill and to discuss some ideas for Equal Pay Day 2012. The call was monitored by Sam Lehman.

Sam Lehman indicated that AAUW will not be putting a great deal of effort on the Pay Equity Bill because they do not feel that the makeup of the current Congress is receptive to the Pay Equity Bill. Instead, AAUW will be working on a bill that will be a follow up to the defeated Wal-Mart vs. Duke Case. As of this date the bill has not been formalized, and AAUW is just referring to it as the Wal-Mart Bill.

Then Sam brought up the issue of Pay Equity Day Programs for 2012 and said that the programs should reflect AAUW issues. The two suggestions from National were to have a Smart Start Workshop or a Cocktails and Convos (I think this is what I heard and Convos stands for conversations). The discussion continued with questions and comments from members who were on the line. Also Sam said that Cindy Miller at AAUW is an excellence resource for ways of communicating. AAUW Readers Discuss What the Dead Know

On Sunday afternoon November 6, nine of us gathered at La Madeleine at Columbia Crossing to discuss What the Dead Know by Laura Lippman. This novel, which came out in 2007, concerns two sisters, Heather and Sunny Bethany, who disappear from a shopping center in 1975.

Lippman says that the "initial shiver" that inspired this story came from the recollection of a case that had the Baltimore / Washington area riveted to the news in that same year: the disappearance of sisters Katherine and Sheila Lyon. (Laura Lippman made a number of changes in order to make this narrative her own - for instance, the Bethany sisters are older than the Lyon sisters were at the time that they went missing, and the shopping center was Security Square Mall rather than Wheaton Plaza.)

What the Dead Know garnered generous praise from critics and reviewers. Members of our group had a generally positive response to the novel, although some interesting questions were raised concerning the characters and the reasons for their actions. All in all, the discussion was highly enjoyable: rigorous, insightful, and illuminating.
