February Branch Meeting

Expert to Speak On Science in Art Conservation

"The Interface of Science and the Arts" is the topic of the program at the next meeting of the AAUW Howard County Branch. The meeting is Tuesday, February 14, at 7 pm at the Ellicott City Senior Center, and guests are welcome. The speaker is Lynne Springer Roberts, a decorative arts historian.

Ms. Roberts will talk about the field of science-based conservation programs and important opportunities in object conservation. She will discuss the joint partnership within museums between the conservator and the curator.

In Ms. Roberts' words, "In the best run museums, these two colleagues really work in tandem under the museum umbrella; and, for the benefit of the general public as well as serious collectors. The curators/ conservators work within the museum on all manner of preventive measures to ensure the physical well-being of every type of art work, regardless of its specific medium. They work against the clock as well as against all the deterrent forces in our physical world."

Ms. Roberts will show a few before and after case studies of conservation 'triumphs' in varying media of the fine arts.

Ms. Roberts graduated with a degree in Art History from Washington University in Saint Louis, Missouri. She served as a curator of decorative arts in major art museums such as The Saint Louis Art Museum, The American and European Decorative Arts Museum and The Art Institute of Chicago. Her own career as a decorative arts historian spanned much of the time during the growth of fine art conservation in this country.

Presently, she sits on the Board of The Winterthur Museum in Wilmington, DE, and is chair of its Academic Affairs Committee, which includes its two celebrated training programs: The Winterthur/University of Delaware Program in Material Culture and The Winterthur/University of Delaware Program in Art Conservation. Winterthur's extraordinary and extensive library is also under the purview of the Academic Affairs Committee.

This practice exam is just like the real SAT exam and can help prepare middle and high school students to do better on the exam, which influences their abilities to get into college. One parent can attend the strategy session with the student.

ADVOCACY UPDATE

From the headlines, you know that Congress is back in session as is the General Assembly. Of course the County Council proceeds apace. The deadline for filing for candidacy for those positions up for reelection this year was January 11. The Board of Education for Howard County has a number of candidates who have qualified to run for re-election or election. Perhaps these pieces of information make you think all is right with the world. Well, let's look at that view.

Congress

Among other initiatives, the President called for the following in his State of the Union message:

- 1. Equal pay for equal work to bring to bear the talents and ingenuity of every person in an economy built to last,
- 2. Affordable higher education to assure the availability of the skills for the new world economy,
- 3. Retention of good teachers who teach beyond the test and rewards for the best teachers.
- 4. Assurance that executive judicial and executive appointments receive an "up or down" vote,

All of these initiatives are ones which AAUW actively supports. Time will tell whether these or any other initiatives come to pass in this or any future session of Congress.

General Assembly

On January 8, a number of members of AAUW Howard County attended the League of Women Voters legislative luncheon. All members of the Howard County delegation were there, except Del. Frank Turner who was recovering from surgery and Del. Steven J. DeBoy, Sr. who was attending another event in District 12A which he shares with Del. James E. Malone, Jr. who was present.

AAUW member Valerie Montague served as master of ceremonies and requested that the delegation respond to the League priorities for 2012. These are:

- -- adequate revenue to protect public services and protection of the environment,
- -- repeal of the death penalty,
- -- legalization of civil marriage,
- -- improve the election and redistricting process.

The responses of the delegation were dominated by the perceived budget issues, prediction of new revenue which will be requested by the governor to meet budget shortfalls and for environmental clean-up as well as county efforts to help meet the costs of pension shortfalls for teachers. These requests have already come to pass.
