Treasurer's Topic of the Month Dues Renewal

Our fiscal year is coming to an end and most of you will be renewing your dues by June 30th. National AAUW has switched to a rolling renewal schedule, so some of our newer members may not need to renew yet. If your dues are due, you should have received an email by now from AAUW National giving you instructions.

If you wish to renew online, follow the instructions in the email, but please make sure you click on Yes for Branch membership; then scroll down to MD2023 – Howard County Branch Dues and check the box. This will automatically select Maryland as your State. Your total amount due should be \$95 (\$72 National; \$10 State; \$13 Branch). If you are a lifetime member, your total due will be \$23 for State and Branch. I encourage you to renew online, as this gives you the opportunity to update your information, such as email addresses, phone, education, etc.

We have two women going to NCCWSL at the end of May. They are Nina Randall who is transferring to Morgan State University in the fall to major in Sociology and Maite Inchaussandague, a 4.0 Freshman, with her sights set on the University of Maryland Smith School of Business. The NCCWSL program takes the women into DC on Thursday evening with dinner on their own. We give the students a prepaid Visa card so they can afford their own meal.

I would like to thank all the members who have helped on education projects over my terms as Education Vice President. We have made a difference in some women's lives, and developed some good relationships with Howard Community College staff. Debbie Munley and I worked with the Office of Student Life to put on the Start Smart Workshop. We have sponsored thousands of dollars of scholarships for the nontraditional women students in Career Links, helping them on their way to a career with a living wage so they can support their families. In recognition of those scholarships we now have a permanent AAUW plaque on the Allied Health Chemistry Lab. The school recognized the need for student food assistance, started a food bank, and Caroline Tunison, Paula Razera, and I have carried over many pounds of food and supplies you members generously donated.

In the Howard County community, we have annually supported the Girl Power STEM festival at Johns Hopkins Applied Physics Lab. I believe Jeannie Parr got us started handing out the self- inflating balloons from the American Chemical Society. They are always a hit with the girls who are in elementary and early middle school. Thanks to Sethanne Howard who got us using astronomy and space as a theme since her own background is astrophysics. Join the Joyful Ruckus!

Did you know that this July is the 100th anniversary of Alice Paul's introduction of the Equal Rights Amendment? GenerationRatify, a group of young women (most under the age of 19) are hosting a convention in Seneca Falls, NY to mark the occasion and to amplify the need to get the ERA certified and part of our US Constitution. Of course, we can't celebrate yet so the focus of the event is cultivating a new generation of ERA activists and setting goals for constitutional equality for the next year including an action plan for finalizing the federal ERA and getting state ERAs passed in all remaining 23 states.

AAUW Maryland has decided to join forces with VoteEquality and Maryland NOW to support these young women as they work to bring about change so that <u>everyone</u> in this country will be treated equally under the law. We will be traveling via caravan from Hagerstown, MD to Seneca Falls, NY! We'll depart from Hagerstown on Thursday morning, July 20th and travel with the VoteEquality RVG (it's a HUGE motor home, dubbed the Ruthless Vote Getter) to NY making a few quick stops along the way to spread the word about the ERA.

I'll be attending the ERA Centennial Convention on July 21st-23rd and hope that you will join me. We are booking a rental home nearby so we'll have reasonably priced accommodations. It's a three-day event with Sunday as a day to soak up a bit of the history of the area. The Convention will be held at the First Presbyterian Church of Seneca Falls where the National Woman's Party first unveiled the ERA-at the exact same podium Alice Paul gave her speech that day, 100 years ago. Public Policy

Public Policy Report

The Maryland General Assembly 2023 session ended on April 10. Eight bills passed; seven were MLAW bills. They are listed here.

- The bill which makes the constitutional right to reproductive liberty a ballot item on the next Maryland general election;
- The bill to make reproductive healthcare available to students at public colleges and universities:
- The bill that repeals marriage as a defense for sexual crimes;
- the bill that holds the new Maryland Gun Control Center responsible for tracking guns surrendered due to final protective orders;
- the bill that absolves trafficked youth from non-violent crimes committed while being trafficked;
- the Collaborative Care Model bill, which expands the very successful model of providing mental health and addiction care management through a primary care physician.
- the Childcare Sustainability Act, which continues supports for childcare that were federally supported during the pandemic; and
- the Reproductive Health Protection Act, which would protect both patients and providers from out-of-state lawsuits and inquiries.

The End-of-Life Options bill and the Emergency Room Wait Time Task Force bill did not pass this session. The Climate Crisis and Environmental Justice Act never was considered during the session.

One of the significant contributors to emergency room wait time was that so many hospital beds were occupied by patients needing mental health beds in mental health facilities. Several bills addressing mental health services, including the collaborative care model above, were passed and should help to address this problem.

On the national level, immediate attention is focused on the expected Supreme Court decision regarding the legality of the Texas ban on the FDA-approved drug, mifepristone.
