Yearly Financial Re-cap and Dues Renewal Information

Our fiscal year ends in June, and I wanted our members to know how we have done financially. Our current cash balance between checking and savings is \$7075. Because of some generous members who gave directly to the HCC Educational Foundation, our branch did not need to use any of our money to fund scholarships. Those donations were credited by HCC to our Branch scholarship fund.

The Branch funded 2 students to attend the National Conference for College Women Student Leaders (NCCWSL). We also donated \$250 to the Maryland Woman of Distinction fund which helped AAUW Maryland meet its goal of \$20K to be a Platinum Sponsor of the event. Secretary of State Susan C. Lee is the Maryland AAUW honoree at the event on June 2nd.

Income from our fundraisers this past year was: Toby's - \$218.50; Horse Spirits Art Gallery - \$940; and other donations from members - \$110

Dues Renewal Info: Our fiscal year ends on June 30th. Most of our members are due for renewal at the end of June. National AAUW has switched to a rolling renewal schedule, so some of our newer members may not need to renew yet. If your dues are due, you should have received an email by now from AAUW National with instructions.

If you wish to renew online, follow the instructions in the email, but please make sure you click on Yes for Branch membership; then scroll down to MD2023 – Howard County Branch Dues and check the box. This will automatically select Maryland as your State. Your total amount due should be \$95 (\$72 National; \$10 State; \$13 Branch). If you are a lifetime member, your total due will be \$23 for State and Branch. I encourage you to renew online, as this gives you the opportunity to update your information, such as email addresses, phone, education, etc.

However, if you wish, you may give your renewal check to me and I will renew for you. Make the check out to AAUW Howard County for \$95 (\$23 for lifetime members) and give to me at any event I'm at or mail to:

Did you know that this July is the 100th anniversary of Alice Paul's introduction of the Equal Rights Amendment? GenerationRatify, a group of young women (most under the age of 19) are hosting a convention in Seneca Falls, NY to mark the occasion and to amplify the need to get the ERA certified and part of our US Constitution. Of course, we can't celebrate yet so the focus of the event is cultivating a new generation of ERA activists and setting goals for constitutional equality for the next year including an action plan for finalizing the federal ERA and getting state ERAs passed in all remaining 23 states.

AAUW Maryland has decided to join forces with VoteEquality and Maryland NOW to support these young women as they work to bring about change so that <u>everyone</u> in this country will be treated equally under the law. We will be traveling via caravan from Hagerstown, MD to Seneca Falls, NY! We'll depart from Hagerstown on Thursday morning, July 20th and travel with the VoteEquality RVG (it's a HUGE motor home, dubbed the Ruthless Vote Getter) to NY making a few quick stops along the way to spread the word about the ERA.

I'll be attending the ERA Centennial Convention on July 21st-23rd and hope that you will join me. We are booking a rental home nearby so we'll have reasonably priced accommodations. It's a three-day event with Sunday as a day to soak up a bit of the history of the area. The Convention will be held at the First Presbyterian Church of Seneca Falls where the National Woman's Party first unveiled the ERA-at the exact same podium Alice Paul gave her speech that day, 100 years ago.
